- In case a national test or final exam is necessary to enter a higher education institution in the student’s country of origin, such test/exam is also mandatory for entering Italian BA programmes (Gao Kao and Yi Kao in China, Vestibular in Brazil...).
- In case the local school system consists of less than 12 years of schooling before achieving the higher secondary school diploma, the following documents are also required:
- Legalized\* and translated university transcripts of one or two years, including exams and marks;
- Certificate of completion of preparatory courses (Foundation Course) issued by Italian or foreign universities

### 3.1 Data retention

For purposes 3(a), (b), (c), (d), (e) and (f), we retain your personal data for the whole duration of the time you spend on Campus and even beyond the 10-year period of limitation from the termination of the relationship to comply with legal obligations and for purposes of judicial protection.

For the mentioned purpose 3 (g), (h) and (i), we retain your data until consent is revoked and we guarantee the exercise of data subjects rights.

For the mentioned purpose 3(j), and (k), we retain your data for 3 years.

### 4. THE SECURITY OF YOUR PERSONAL DATA

Your data will be processed using equipment that guarantees their confidentiality, integrity and availability. The processing is carried out on paper and through computerised and/or automated systems and will include all of the operations or sets of operations envisaged in Art. 4 of the GDPR which are necessary for the data processing,

including communication with the subjects assigned to the processing itself. The data will not be disseminated; however, they will or may be communicated to public or private entities or individuals who operate within the context of the purposes described above.

### 5. WHO CAN ACCESS YOUR PERSONAL DATA

## ADMISSION PROCEDURE

Gap Year Programme  
Academic Year 2024/25

### 1. ADMISSION TEST

NABA intends to understand your motivation and attitude in undertaking the chosen programme. A strong motivation and solid awareness of the contents of the programme guarantee your commitment and determination which are necessary to attend the Academy.

NABA will take into account your creative attitude and your way of dealing with a project. You are asked to work on:

- 1.1 an artistic statement
- 1.2 a project assignment specific to the programme of your choice or/and
- 1.3 a portfolio of projects to enhance your application file

#### 1.1 ARTISTIC STATEMENT

Please write an essay (max 500 words) elaborating the following questions. In the next future:

- what job would you like to do after you graduate?
- why did you choose NABA to achieve that?
- what are your favorite means of expression?
- what or who inspires you?
- how living and studying in Milano/Roma will positively influence your work?

#### 1.2 PROJECT ASSIGNMENT

Your artistic skills are an important element for evaluating your application to NABA Gap Year Programme. Together with your Artistic Statement, the following assignments will enable our Faculty to get to know you, your skills and your commitment. In order to develop your project assignment, please follow the guidelines here below, related to each Gap Year Programme.

##### Project Assignment for the Gap Year in Design

Your design task shall include:

- 2D images designed and created by you:
  - at least 2 hand drawings (various techniques may be used)
  - at least 2 digital drawings, photos, collages, etc.
- Design is a subject closely connected to objects, their functionality and the environment surrounding them. You are asked to:
  - a) choose an object with a specific function;
  - b) give the object a second life, by changing its function and shape (any material and technique can be used);
  - c) represent it:
    - take a picture of the object before and after the morphing;
    - describe the process and the concept behind it.

##### Project Assignment for the Gap Year in Fashion Design and Gap Year in Fashion Marketing Management

- 1) Choose 3 subjects and make 3 research collecting images/pictures related to the chosen subjects.
- 2) Write a short description or list some key words for each subject.
- 3) Develop 3 mini projects related to the chosen subjects, one for each of them. Projects may be pictures, or drawings, or

outfit sketches, or technical drawings designed by you, that show your skills. Each of them should include at least 3 images. Here below an example of project:

- SUBJECT: Urban
- RESEARCH: Collect images/pictures of places and people coming from one or more cities
- DESCRIPTION: List a series of keywords related to the Urban Concept
- PROJECT: Create an outfit or an accessory - man/woman/kid/pet (also only one of these different typologies) - related to the research
- HOW:
  - Use collage technique assembling different existing images/pictures
  - Draw fashion figures or technical drawings of your garment/accessory

##### Project Assignment for the Gap Year in Graphic Design and Art Direction

Your GRAPHIC DESIGN task shall include:

- FOR STUDENTS WHO HAVE ALREADY ATTENDED COURSES RELATED TO GRAPHIC OR ADVERTISING
  - Two graphic design projects: research and final design on a logo or on a corporate identity or present a publishing project (magazine or poster layout).
  - Two advertising projects: research on a press campaign and final creative proposals.
- FOR STUDENTS WHO HAVE A BACKGROUND NOT RELATED TO GRAPHIC OR ADVERTISING
  - Make a selection of illustrations/pictures among your creative works.
  - Make a selection of photos among your creative works.
  - Select 2 famous logos (one example that you consider effective and one example that you consider ineffective) and describe their positive and negative features.
  - Select 2 famous ads (one example that you consider effective and one example that you consider ineffective) and describe their positive and negative features.

##### Project Assignment for the Gap Year in Comics and Visual Storytelling

For all students, both with or without prior knowledge in art or scriptwriting.

##### BRIEF

- Select 2 characters from the Marvel universe – a hero and a villain - and describe how their physical and emotional characteristics, relationships and conflicts are expressed in the comic stories.
- Write the plot for a 10-page comic story, featuring two friends who miss their train and must find an alternative method to reach their destination. The text must be between 2000 and 2500 characters, spaces included.
- Create a comic page based on the developed plot. The page must include at least 6 panels, up to a maximum of 10, telling the initial scene of the story. If drawn, it can be done either in pencil or ink and must include the dialogue between the characters. If scripted, each panel must consist of a descriptive text followed by dialogue (see example below).

**Panel 1:**

John and Steven stand in front of a schedule board. They look pensive and worried.

Dialogue:

John: There's another train, but it's in two hours.

Steven: Darn. We'll be missing all the fun.

→ How to present the material

The comic page can be drawn or written in script form. The applicant can choose based on his or her preferences. If drawn, it can be in pencil or ink. Colored pages will not be accepted. The page can be drawn traditionally or in digital format and submitted digitally. The page must consist of at least 6 panels, up to a maximum of 10, and include dialogue.

**Project Assignment for the Gap Year in Painting and Visual Arts**

→ A description of the context of the sequence: is it for a short or feature film? a TV or web series? An app or a video game, and of what kind? (adventure, puzzle, FPS, platform, etc...), an advertising or other?

→ Please also add a brief explanation about the techniques you would apply, if aware of it.

→ A description of the intended audience (teenagers, adults, etc.).

→ Mention digital productions that have inspired you: movies, music, games, animations, art etc. (3-5 items); Include details of the selected works (title, author, year and other significant details). Describe what you like about each item and why it inspires you. Include at least one image per item.

**Project Assignment for the Gap Year in Film and Animation**

Your task shall include an example of your storytelling skills. It shall be articulated as follows:

→ A plot (max length: 100 words).

→ Visual and narrative references (movies, novels, video games, etc. Max 10 items are accepted; please provide for each of them: an image, a caption and a very short explanation for your choice).

→ The medium through which the plot is displayed (short film, long film, TV series, web series, video game, photo reportage, etc.). Please also add a brief explanation about the techniques you would apply, if aware of it

→ A description of the audience (teenagers, adults, etc).

**Project Assignment for the Gap Year in Set Design**

Your task shall include:

→ One project work possibly related to the design of a performance/exhibition space (the format of the presentation is free).

→ One drawing with an emphasis on technical skills or one photography with an emphasis on visual skills and photographic technique.

→ Sketches or notebook pages illustrating set design ideas.

Your task shall include:

→ One art project work (the format of the presentation is free).

→ One drawing with an emphasis on observational skills and/or personal expression or one photography with an emphasis on visual skills and technique.

→ Sketches or notebook pages illustrating visual art/design concepts.

→ One art/design related work from other disciplines (for example jewelry or crafts) - if you have any.

**Project Assignment for the Gap Year in Creative Technologies (New Technologies for Applied Arts)**

Your task shall demonstrate your digital production predisposition. It shall contain the following items:

→ A storyboard of an original sequence of your creation. It can be a movie or a game scene, or a work of animation or 3D art or motion graphic of any kind. It must include between 6 and 12 frames with appropriate description. It can be hand or computer made.

→ One art/design related work from other disciplines (for example exhibition design, visual arts, installations, interior design etc.).

→ For each work write a detailed description including Title, Year and Technique.

**1.3 PORTFOLIO OF PROJECTS**

(Alternative option to the project assignment)

Creativity is not an abstract exercise, on the contrary, it requires the ability to contextualize and elaborate information and look for new solutions with an open spirit capable of listening and interacting with our environment. The goal of a successful portfolio is to tell a visual narrative of your passions, explorations and abilities.

All materials submitted should be clearly labeled with the applicant's name and contact information and cannot be returned.

Digital, paper or internet-based works can be submitted.

Portfolios are reviewed on the following qualitative measures: aesthetic awareness, composition, drawing, design, colour

perception, spatial perception, quality of presentation, technique and originality.

Favourable consideration is given to strong 2-D and 3-D work that shows fully rendered pieces, excellent craftsmanship, attention to technique, and original design.

**Guidelines to portfolio preparation:**

A portfolio of projects is the presentation of yourself, of your previous academic and/or professional and/or amatorial works. There is no need to include many projects rather a selection of your strongest works that will let us understand your skills and potentials.

**What to include:**

→ 5 to 10 projects divided into separate folders.

Submissions may include drawings, illustrations, paintings, computer graphic, design, printmaking, collage, photography, sculpture, jewellery, fashion, furniture or videos.

Portfolio pieces may represent classroom assignments as well as independent projects. The portfolio should be purposeful,

demonstrate originality of concept, use of appropriate materials and visual literacy.

Each project should have a pdf description containing: title of the project, year of production, information if it is a project developed at school, on your own, ...

#### Digital formats:

→ Photos, graphic projects, drawings, sketches: PDF (including fonts), JPG or PNG 300 dpi

→ Websites: complete folder including html, css, images, swf, other. If it is online: please provide us with the url web

→ Videos: MPEG4 or AVI

→ Texts, research or presentations: PDF

Applicants should not submit work copied from film, television, photographs, magazine/book illustrations or other sources.

If you are filing an application for **Fashion Design**, you might want to consider the following suggestions to include in your portfolio:

→ Research images for fashion design, using a range of materials (drawings, notes, photographs, images of items that you find inspirational for fashion design).

→ Images of your fashion design sketches (sketches demonstrating your development of a fashion theme).

→ Images of finished fashion illustrations (using colour and demonstrating your skills of presentation, these could be hand-drawn, painted, collage or computer images).

→ Images of any other creative work. We leave the decision of what to include to you.

If you are filing an application for **Design**, you might want to consider the following suggestions to include in your portfolio:

→ 2D images designed and created by you:

→ at least 5 hand drawings (various techniques may be used) optional:

→ digital drawings, photos, collages, etc.

→ 3D work including experimentation and development.

→ Finished work accompanied by a short explanation of the piece and your thinking.

→ Idea generation.

→ Inspiration and research material.

#### 1.4 RESULTS

In the global evaluation, NABA will take into account the applicant's interests and aptitudes for advanced studies and potential for success at NABA Gap Year Programme and the related professional role. The lack of specific preparation in some of the subjects that are part of the admission test, due to the different educational background that a student might have, will not result in prejudice to the final admission, on condition that the vocational elements have been positively assessed.

**Once the assessment is complete, you will receive a feedback about the final result within 5 working days. If the result is positive, the admission letter will be issued and sent to you.** NABA may offer you a conditional admission if you do not have yet submitted the language certificate, copy of your diploma (the last one applies to BA applicants only). If you are conditionally accepted, you will have to make sure you submit the missing documents by the course beginning.

#### 2. LANGUAGE REQUIREMENTS

NABA Programmes are taught in Italian or English. Students are required to submit evidence of the knowledge of the language according to the chosen programme. The language certificate shall be submitted within one month before the beginning of the programme and should not be older than 2 years.

The requested level for Italian is an intermediate level (complete B1 - according to CEFR). Student can also take CILS, CELI, CERT.IT, PLIDA provided that the final result is equivalent to complete B1.

## **5. ENTRY REQUIREMENTS FOR THE GAP YEAR PROGRAMME**

Students wishing to enrol in the Gap Year Programme are required:

→ to possess a **diploma equivalent to an Italian secondary school diploma** (maturità);

→ the diploma must be translated into Italian and legalized by the Italian Embassy or Consulate in the country where the diploma was issued, regardless of the school's actual location. For example, the diploma of a German school which is located in France must be validated by the Italian Consulate in Germany. \*

→ the foreign diploma must be obtained at the end of a period of study lasting at least 12 years;

→ if the diploma was obtained after 10/11 years of education, it must be integrated with additional 1 or 2 years of college or university; all exams must be passed and admission respectively to the second or third year of your university must be granted;

→ the **International Baccalaureate (IB)** diploma is valid for admission to an Italian university;

→ the International Baccalaureate "certificate" is not valid for admission to an Italian university;

→ the **U.S. High School diploma** must be supplemented by 3 advanced placement tests that relate to the chosen programme, or by 2 AP tests related to the chosen programme plus 1 AP test in Italian language and culture if applying for BA run in Italian language.

→ **GCE diplomas** are valid only if they demonstrate obtaining at least 3 subjects at advanced level (full A levels/A2) related to the requested programme.

→ In case a national test or final exam is necessary to enter a higher education institution in the student's country of origin, such test/exam is also mandatory for entering Italian BA programmes (Gao Kao and Yi Kao in China, Vestibular in Brazil...).

## **5.1 CONSULAR PROCEDURES**

Students meeting the requirements listed at Point 5 are requested to contact the Italian Embassy or Consulate in order to:

**Legalization of the higher secondary school diploma (only for students who wish to proceed studies with NABA BA degree)**

1) Legalization of the higher secondary school diploma (with official translation in Italian language) by the competent authorities in the country where the diploma was issued. Translation is not needed for documents written in English, French, or Spanish.

If you are not yet in Italy, the translation must be completed according to the rules set by the Italian Ministry of Foreign Affairs and International Cooperation (MAECI).

If you are in Italy you can go to a district court (tribunale) and have your documents translated by a sworn translator, who cannot be the person who holds the qualification or title (traduzione giurata).

2) In case a national test or final exam is necessary to enter a higher education institution in the student's country of origin, such test/exam is also mandatory for entering Italian BA programmes (Gao Kao and Yi Kao in China, Vestibular in Brazil...).

**3) In case the local school system consists of less than 12 years of schooling before achieving the higher secondary school diploma, the following documents are also required:**

- legalized and translated university transcripts of one or two years, including exams and marks;
- certificate of completion of preparatory courses (Foundation Course) issued by Italian or foreign universities.

The legalised and translated documents will be issued directly to you. Please make sure you submit them to NABA International Admissions Office as soon as available together with a copy of the original higher secondary school diploma.

- Submit the language certificate (if not previously provided)
- Pay the balance of the tuition fee
- Confirm your day of arrival in Milan/Rome

#### 6. LEGALIZATION (ONLY FOR STUDENTS WHO WISH TO PROCEED STUDIES WITH NABA BA DEGREE)

- Translation into Italian – made by a certified translator – of the student original higher secondary school diploma (or substitute certificate) legalised by the competent authorities in the country where the diploma was issued.
- Certificate of the University Suitability Test for those countries/education systems that require a specific test to enter a higher education institution (ie: Gao Kao and Yi Kao in China, ENEM in Brazil, Selectividad/EBAU in Spain).

#### 7. STUDY VISA

Non-European citizens must apply for Study Visa. The visa must be requested to the Italian Diplomatic-Consular Representatives in the student country of residence. For Gap Year Programme it is not necessary to pre-enrol at the Italian Diplomatic-Consular Representatives in the student country of residence.

#### 4. PERMIT OF STAY

Non-European citizens should apply for the Permit of Stay to the Police Office located in the city where they dwell. NABA Academic Registration Office will provide students with the necessary support throughout the process.

*WHEN: within 8 days from the arrival in Italy.*



**8. GENERAL CONDITIONS**

1. In accordance with the article 52, 1st paragraph of the Consumer Code: for signed contracts, contractual proposals of registration at distance, and for any contract negotiated outside the site of "Nuova Accademia" (NABA), it is recognised to the student the right to withdraw from the contract without the risk of incurring in any extra expenditure and without the payment of any penalty, within fourteen working days from the conclusion of the contract (upon receiving the contract/enrolment form). The student willing to withdraw shall send a written notification by registered mail containing name and surname, the address of the student, date and place, student's signature; it will be considered termination date, the date when the registered mail will be received. The written notification shall be addressed to: Nuova Accademia Srl – Via C. Darwin 20, 20143 Milano (MI).

2. If a student withdraws from the contract lawfully, he/she has the right to get a refund of all the payments made order to NABA, except for the application fee.

3. NABA will activate courses only if a minimum of participants will enrol. If a minimum of participants will not be achieved, the course will not take place. NABA will promptly communicate to the student if a course will be run or not. NABA will inform students at least 30 days prior the beginning of the course whether it will not be run. In such event, NABA will refund the students in the shortest possible term. NABA is exempted by any extra costs incurred by students (i.e. travel, food, accommodation...) for the enrolment and admission process.

4. NABA reserves the right (up to 30 days before the beginning of the programme) to:

- Cancel a course
- Change a course
- Change location of classes.

The European and International student must pay the total amount of the tuition (Pre-enrollment fee and tuition fee) no later than 30 days before the start of the chosen Course. Students who withdraw prior to 30 days before the start of the Course will be entitled to a full refund of the amount paid, excluding the amount paid as Pre-enrollment Fee. Students who withdraw in the 30 days prior the start of the Course by filling the appropriate form will not be entitled to a any refund of the amounts paid up to that time. If, on the other hand, the student should be affected by a final rejection order for a visa application, NABA shall refund to the student all the sums that he/she has paid up to that time.

Alternatively, the student shall have the opportunity to defer his/her participation to another course or subsequent intake, notifying this intention to NABA by means of written communication. This faculty must be exercised by the student no later than 12 months from the day of notification.

NABA, 30 days prior the start of the Course for which the student initially enrolled, will not accept student applications for another Course or subsequent intake unless the request is caused by force majeure and/or problems regarding Visa application.

In the event that NABA accepts the application form to enroll in another Course, subsequent intake, the student is obliged to pay the entire annual amount of the Academic contribution, tuition fees and the application of the penalty of € 500,00 by the start of the Academic Year to which they were initially pre-enrolled/enrolled.

In the event that, however, the student decides to withdraw 30 days before the start of the Course, to enroll in the following semester and, if this request is accepted by NABA, he will be require to pay, no later than 3 months before the start of the subsequent intake chosen, a fixed fee of Euro 500,00, as well as the payment of the total amount of the tuition fee. NABA, if the student does not pay the above-mentioned sums within the above mentioned terms, reserves the right to cancel the student's course enrolment and will have the right to retain any fee paid by the student up to that moment.

If NABA withdraws, the student shall be entitled to demand from NABA double the Pre-enrollment Fee already paid, excluding the regional tax.

5. Enrolment to a course, together with the payment of the required enrolment fee, creates a binding agreement to follow the course and to pay the full fees. NABA reserves the right (excepting what's stated on paragraphs 1-2-3) to dismiss or expel a student at any time for non-payment of fees or any other due amount, failure to meet the ongoing attendance requirement, late commencement of study and/or withdrawal from courses commenced under any circumstances (personal reason, health problem, family related problem...). No refunds will be granted to the student (including any prepaid fees or deposits) dismissed under this paragraph.

6. Classes will take place according to what is foreseen in the yearly academic calendar.

7. NABA guarantees to students access to educational areas for all the duration of classes as per the Academic Year timetable, and the number of hours, which are necessary to complete the programme. Further access to campus spaces is subject to didactic needs and logistic availability.

8. NABA is not responsible for any deficiency or delay in the performance, in whole or in part arising from or attributable to failure to comply with any obligation,

caused by or attributable to acts and failure to comply with obligations by third parties, events, omissions and/or accidents beyond possible and reasonable control, such as, but not limited to, strikes or other disputes involving our staff or other third-party personnel, natural disasters, wars, revolts, civil uprisings, voluntary damages, in accordance with any law or governmental regulations, rules or directives, accidental breakdowns of plant or machinery, fires, floods, storms, pandemics, epidemics or other spreads of diseases and/or infections in the failed public supply of energy and services, telecommunications and/or Information Technology.

9. Each and every Intellectual Property Rights that will result from the creative and/or inventive activity inherent to the activities, studies, experimentation, planning carried out by individual student or groups of students, within an educational project, under the guidance of NABA 's teachers and/or directors, and any and all materials created, designed and carried out by students during the academic activity (including, by way of example but not limited to: notes, presentations, texts, projects or other) will be exclusive property and ownership of NABA and is intended by the student as of now transferred definitively and free of charge to the same, which will have every right of exploitation, economic use and disposal of it for any reason (including, by way of example but not limited to, advertising purposes, promotional, internal strategy, information or research, educational or experimental). Consequently, NABA will hold each right to register the Intellectual Property Rights and copyrights in national, European and international registers, without prejudice to the student right to be recognised as author.

10. Enrolment fee and tuition fee do not include photocopies, lecture notes, colour printings, materials to be used for all project workshops, as well as computer rendering of the final thesis, participation to exhibits or contests.

11. Students are required to comply with the regulations regarding the norms of behavior which have to be respected inside the Academy (the Code of conduct), the norms of use of the students email account, the Academy computers and the personal badge available in the personal area of the NABA website in the section Didactic Regulations. Breaches of the norms may lead to the application of disciplinary actions corresponding with the seriousness and recurrence of the facts, and which may include the temporary or permanent suspension from the Academy.

12. NABA reserves the right to seek compensation for any damages incurred by the student to the premises and equipment. The student is required to use them correctly and to respect the cleanliness of the premises and areas of common use.

13. It is forbidden to bring dogs and others animals in NABA.

14. NABA is not responsible under any condition for any object lost or property left unattended in the Academy structures.

15. The enrolment to a course is under the conditions that students have all the required papers to enter the country and live in Italy as per the Italian law in force during the Academic Year in which the mentioned students want to study at NABA. NABA is not responsible for the release of the permit to study in Italy and for the VISA, which will have to be obtained by the students themselves and at their expenses from the competent authorities. This is also recognised in the event that the student requests and obtains the transfer of an internal course during the enrolment period. Students are aware and agree that should they not be able to attend the chosen course for one of the reasons mentioned above or any other reasons, NABA has the rights to keep any sum paid to the academy in order to cover the up to then expenses. NABA has the right to claim for greater damages. If the course hasn't started yet, NABA commits itself to refund the fees already paid by the student (application fee excluded) only if VISA is rejected by the competent Authority and only if the student informs NABA by a writ ten notification together with the rejection declaration is sued by the Italian Embassy or Consulate.

16. Any controversy falls within the competence of the Milan legal court..
