



INTRODUCTION

Welcome to NABA!

Embarking on a course of study at an Academy of art and design means putting energy, creativity, and passion at the service of one's talent. At the same time, it is important to be clear about the practical aspects that shape the educational experience, so as to approach it with confidence and awareness.

This guide has been created to present, step by step, the numerous opportunities that NABA offers to students and their families, from the income brackets to the various forms of financial support available. Here is possible to find useful information on the enrolment process, the tuition fee definition, the required documents, and the relevant deadlines.

The aim is to provide a comprehensive tool that consents an easy navigation through NABA's administrative system, allowing to focus the energy on what truly matters: **artistic growth and the development of a solid professional future.**

ENROLMENT

To begin a two-year programme at NABA, the expected annual investment is € 21,850, which corresponds to the highest income bracket. NABA also offers five lower brackets, designed to support young talents and meet the needs of each family.

To request assignment to a reduced fee bracket, the documents must be submitted to the Student Administration Office, in PDF format and accurately translated into English, to the email address tuitionfees@naba.it.

The assigned income bracket applies for the year of enrolment and must be re-confirmed for each following year by resubmitting the required documentation **by November** of every year. The tuition for subsequent years will initially be calculated based on the previous year's bracket, and any necessary adjustments will be made once the new documents have been reviewed.

Who needs to submit financial documents?

If the box for exemption corresponding to the 6th income bracket was selected in the enrolment form, there is **no need to submit any financial documents**. It is possible to skip this step.

! Note: if the required documentation is not submitted or is found to be significantly incomplete, NABA will automatically assign the highest income bracket.

SUBMISSION PROCESS

Admitted students must provide within the established deadlines and exclusively in PDF format:

→ Completed **enrolment form**, signed by the student and by both parents, with all pages included. **Only handwritten signatures are accepted.**

→ **Copy** of the bank transfer for the Enrolment Fee and the Regional Tax;

→ **Copy** of the student's Identity Document and Fiscal Code;

→ **Copy** of the Identity Documents of both parents and any additional guarantors.



INCOME BRACKETS

FAMILY UNIT OF BELONGING/ORIGIN

NABA considers the following individuals as part of the conventional family unit:

- The student;
- The student's parents, even if legally separated, divorced, or not married to each other.

! Note: *for the calculation of the income bracket, the combined income and assets of the student and both parents will be taken into account.*

INDEPENDENT STUDENT

A student can be considered independent from their family of origin if the following conditions are met:

- **Autonomous residence:** the student must have lived outside the household of the family of origin or relatives, as evidenced by family and residency certificates, for at least two years prior to submitting the enrolment application. The residence must not be owned by any member of the family of origin or relatives (the student must provide a rental contract or property deed for their own residence);
- **Own income:** the student must have a gross annual income of at least € 12,000, legally declared over the past three years (income from employment under a family member or rental income from properties is not included).

If both requirements are met, the student must provide:

- **Tax returns** for 2023 and 2024;
- **Rental contract or property deed/land registry extract;**
- **Supplementary Family Declaration** – Annex 1 (p. 11);
- **Bank account and financial investment statements as of 31/12/2024.**

! Note: *if the above requirements are not met, the student must submit, in addition to their own documents, the financial documentation of their family of origin, which will be used to determine the applicable income bracket.*

REQUIRED DOCUMENTATION - Tax year of reference: 2024 calendar year

To determine the applicable income bracket, each member of the family unit must provide:

→ Certificate of Nuclear Family Composition;

→ **Integrative statement of family income** (see Annex 1, p. 11) which shall be signed in order to allow the processing of the data contained therein and duly completed in full with particular reference to real estate market value, company investments and percentage of involvement, incomes that are tax exempt and any income that, as a result of its nature, is not included in the income tax return forms (documentation relating to the same is to be submitted);

→ **Tax return:** photocopy of the fully completed official income and property tax declaration (income tax return) of all members of the family unit. Documents attesting pension and employment income must be provided by the Ministry of Finance or by the Financial Administration of the student's country of origin. If the official income tax return is not available, it is necessary to present a certificate issued by the Revenue Offices attesting to the absence and specifying the above-mentioned fiscal year;

→ **Real Estate** owned by family members, indicating the market value of those Real Estates, and built areas in square metres. These details are required for every family member per each Real Estate. All real estates are valued at 10% of the market price. Only for the principal House with a mortgage, the value is 5% of the market price. It is required to enclose the mortgage agreement;

→ **Photocopies of bank statements and financial investments as of 31/12/2024** (stocks, shares and/or stakes in funds-capitalisation insurance policies). All moveable assets are valued at 5%;

! Note: *the Academy will evaluate the submitted documentation, verifying that the included information is complete. If verifications reveal that the content in declarations made are untrue, the Academy will be forced to take necessary action. Please retain a copy of all the submitted documentation.*



CALCULATION OF THE INCOME BRACKET: HOW IT WORKS

Income bracket evaluation is commensurate with the economic, financial and real estate situation of the student's family.



! Note: only for the principal House with a mortgage, the value is 5% of the market price. It is required to enclose the mortgage agreement, the percentage applied to the cadastral value is reduced to 5%.

DEADLINES AND AMOUNTS A.Y. 2026/27

The total amount and the instalments depend on the assigned income bracket. Here are the main deadlines for all brackets:

- **First instalment**
Fixed amount to be paid upon enrolment: € 5,000 (of which € 4,810 is the Enrolment Fee and € 190 is the Regional Tax).
- **Second instalment - 1 September 2026**
Tuition fee (the amount varies according to the income bracket, see details in the table).
- **Third instalment - 10 January 2027**
Tuition fee (the amount varies according to the income bracket see details in the table).
- **Graduation Thesis Fee**
The Graduation Thesis Fee, in the fixed amount of € 540, is to be paid at the beginning of the second Academic Year, together with the registration for the programme.

! Note: starting from the second academic year, the amount of the enrolment fee and the tuition fee will increase by a fixed and predetermined rate of **2,7%**.

Do the income brackets allow for a tolerance?

Yes. If the calculated income bracket exceeds the maximum limit by an amount equal to or less than € 2,000, NABA will automatically assign the lower bracket.

ACADEMIC MASTER’S PROGRAMMES DEADLINES AND AMOUNTS A.Y. 2026/27

The tuition fee for the one-year programme’s attendance is € 19,300 for EU and EFTA citizens. Here are the details:

Fixed amount to be paid upon enrolment: € 5,000
- **Second instalment - 1 September 2026**

- **Graduation Thesis Fee - 1 September 2026**
€ 540
- **Third instalment - 10 January 2027**
€ 6,880
- **Annual Total**
€ 19,300
